Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. |
| WHAT? | The types of personal information we collect, and share depend on the product or service you have with us. This information can include: Name, email address, internet protocol (IP) address, address, social security number, date of birth, signature Net worth, assets, income, investment experience, employment information Financial account number, financial account balances, trading history, payment history |
| HOW? | All financial companies need to share customers' personal information to runtheir everyday business. In the section below, we list the reasons why financial companies can share their customers' personal information, the reasons why CCS and our Financial Professionals choose to share personal information and whether you can limit this sharing. |

| Why can't I limit all sharing? | Federal law gives you the right to limit only: Sharing for affiliates' everyday business purposes—information about your creditworthiness. Affiliates from using your information to market to you. Sharing for nonaffiliates to market to you. State laws and individual companies may give you additional rights to limit sharing | | | | |
